Each participant is fully aware, completely understands, and accepts that participation in any Show or Event (including virtual) organized by Maui Horse Show Association, Inc whether as a contestant, independent contractor, employee, volunteer, exhibitor, sponsor, or spectator, is dangerous and that the events and activities associated with, relating to, arising out of, and concerning this participation present substantial, serious, and real risks of personal injury or death to the participant, and the loss of, damage to, or destruction of the participant's personal property, including livestock.

MHSA, Inc does not request proof of equine vaccinations. Individual barns, however, may require proof of equine vaccinations for participation in sanctioned MHSA, Inc events at their facility. The MHSA, Inc rule on vaccinations is subject to change. Participants accept and acknowledge that if the location does not require proof of equine vaccinations, they are participating in the event at their own risk and should be mindful of preventative measures needed in this situation.

In consideration of being permitted to participate in any Show or Event (including virtual) organized by Maui Horse Show Association, Inc the participant for himself/herself and all persons under his/her management and control, including minor children, does acknowledge the dangers inherent in horse-related events, and in the participation of the Maui Horse Show Association, Inc Shows & Events (including virtual) fully and completely accepts and assumes these substantial, serious, and real risks whether or not apparent, known, unknown, foreseen, unforeseen, present or contingent, and whether or not caused by any negligence of the Released Parties, or the negligence of any contestant, volunteer or spectator including but not limited to, any negligence associated with the design or designing, staging, supervising, maintaining or in any way presenting, conducting or sponsoring the Event, further does agree to use extraordinary care and prudence in his/her activities and those of charges, and does:

HEREBY RELEASE, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the organizers of any subdivision thereof, chairmen, agents, officials, judges, and does:

HEREBY AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS Maui Horse Show Association, Inc, it's sponsors, it's agents, servants, employees, and representatives from any claim, demand, or liability for personal injuries or property damage arising from participation or use and enjoyment of the event and facilities.

ASSURANCES. The participant fully understands and agrees that this Release is to be interpreted and applied in the broadest and most comprehensive manner in favor of the RELEASED PARTIES. The participant agrees that he/she has full power, authority, capacity and right without limitation to read and agree to and perform this Release. This release shall be and is binding upon the participants and his/her spouse, legal representatives, heirs, successors and assigns. The undersigned agrees that the laws of the State of Hawaii govern this Participation Release. The participant also agrees that upon entry to any event, he/she has read and understands said agreement.

COVID-19 ACKNOWLEDGEMENT OF RISK

I am aware of the risk of contracting Covid-19 while in proximity with others during this time of pandemic. I acknowledge that although Maui Horse Show Association, Inc encourages reasonable precautions to be taken (such as regular hand washing, sanitizing of equipment, and social distancing), it is my responsibility and choice to follow through with such precautions.

I acknowledge that even if precautions are taken, I may contract the disease.

The Ranch hereby grants the Volunteer or User identified above a revocable license to use Ranch Property, subject to the terms of this Waiver. Volunteer or User may enter upon Ranch Property to conduct volunteer, recreation or other activities only on the effective date of this Waiver.

RIGHT TO TERMINATE WAIVER RESERVED:

The Ranch reserves the right to terminate this Waiver and Volunteer or User's use of Ranch Property at any time in its sole discretion, and upon such termination Volunteer or User shall promptly cease his or her activities upon Ranch Property and immediately leave the Ranch Property.

SAFETY:

Ranch Property is steep and rocky and includes active livestock pastures and other areas with hazards and obstacles. Volunteer or User shall at all times conduct him or herself in a safe and prudent manner. Horseplay or any other activity that is likely to cause risk to other volunteers, other users, Ranch employees and invitees, Ranch livestock or property, is strictly prohibited. Volunteer or User agrees to abide by all directions and instructions given by the Ranch. Failure to abide by such instructions shall be grounds for immediate revocation of Volunteer or User's license to use Ranch Property. Volunteer or User shall be responsible for any damage, injury, losses or costs caused by Volunteer or User's use of Ranch Property.

VOLUNTEER OR USER ASSUMES ALL RISKS AND RELEASES THE RANCH FROM ALL CLAIMS AND LIABILITY:

Use of Ranch Property has inherent risks, hazards and dangerous conditions. Volunteer or User acknowledges that he or she knows and understands the scope, nature and extent of the risks and hazards involved in using Ranch Property, and voluntarily assumes the risk that such use may result in damage to Volunteer or User's vehicle or property or injury or death of Volunteer or User. Volunteer or User fully and forever discharges and releases Haleakala Ranch Company and its officers, directors, shareholders, employees, agents, and insurers ("Released Parties") from any and all liability, claims, demands, actions, and causes of action whatsoever arising out of or in any way resulting from personal injuries, conscious suffering, death or property damage that result from Volunteer or User's use of Ranch Property. This release includes loss, damage, suffering, injury, or death resulting from negligence of the Released Parties and any other cause or causes to the maximum extent permissible by law. Volunteer or User agrees not to institute any suit or action at law or otherwise against the Released Parties, nor to initiate or assist the prosecution of any claims for damages which Volunteer or User may hereafter have by reason of damage to Volunteer or User's property or injury or death resulting from use of Ranch Property. Volunteer or User agrees to indemnify, defend and hold harmless the Released Parties from any and all losses, claims, actions, costs, expenses or proceedings of any kind which Volunteer or User may initiate or which may be initiated by any other person, entity or organization relating in any way to Volunteer or User's use of Ranch Property. This includes reimbursement of all legal costs and reasonable attorneys' fees incurred by the Released Parties, or any of them, in connection with any suit or action which may be threatened or filed in connection with such use.

THIS IS A BINDING CONTRACT THAT IS IN EFFECT NOW AND SHALL REMAIN IN EFFECT IN THE FUTURE:

Volunteer or User expressly agrees that this document is a binding Waiver, pursuant to which Volunteer or User freely gives up certain rights and makes certain binding promises. This Waiver shall continue at full force and effect at all times and shall be binding on Volunteer or User's heirs, executors, personal representatives, administrators, estate, spouse, marital estate, and assigns. In case any one or more of the provisions contained in this Waiver shall be held void or unenforceable for any reason, the enforceability of the remaining provisions contained herein shall not be impaired thereby.
