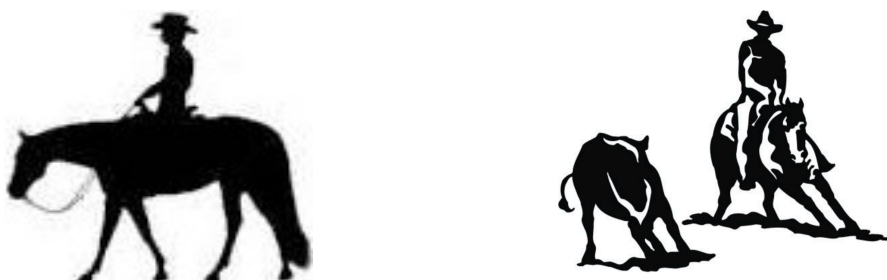

## **JUDGE BIOGRAPHY**

### **TYLER SMITH**



Smith and Flavin Equine is a professional horse training company that provides clients with everything they need to own and ride competitive western performance horses in Hawaii. The company is based on the North Shore of Oahu and is owned and operated equally by trainers Tyler Smith and Meghan Flavin. Meghan has spent many years working under several professional horse trainers where she had the opportunity to train and show performance horses of all levels and ages. Tyler was born and raised into a respected family in the Hawaii horse community and spent over four years working under a top reining horse trainer in Colorado. Tyler has competed in numerous reining horse shows including three-year-old futurity classes. In Hawaii's western horse community, the Smith family legacy began with Tyler's grandfather, the late, Max Bigler Smith. Dr. Smith was known as one of Hawaii's great horsemen. The mission of this company is to create a new wave of excitement based on top level reining and reined cow horse training. With their combined knowledge and diverse skills, Tyler and Meghan provide a well-rounded program that can take horses in different directions based on their natural abilities.

Currently, Tyler and Meghan are both active in the show industry with Meghan focusing on NRCHA shows and Tyler on NRHA shows. Their operation is based both out of Waialua, Hawaii and Colorado. The show season for Smith and Flavin Equine is focused on the summer months when Meghan stays full time in Colorado to train and show while Tyler travels back and forth from Hawaii to Colorado. This program provides opportunities for horse owners and students in Hawaii to be involved in the mainland show horse industries, with the option to send horses and riders to compete for experience and earnings at NRCHA and NRHA shows.

## **GENERAL GUIDELINES**

**Western Shows are covered by the rules and specifications of the current MHSA, USEF, AQHA (for Versatility Ranch Horse Classes), NRCHA (for Working Cow Horse Classes) 2025 Rule Books. Proper Show attire MUST be Worn.**

### **PERSONAL:**

Riders must wear a western hat or ASTM approved riding helmet, long sleeved shirt with collar, jeans or pants, and western boots. Chaps and spurs are optional. Improper or incomplete attire may be subject to being penalized, up to possible disqualification. Exhibitors must wear an exhibitor number (supplied by Show Management).

### **TACK:**

Entries shall be shown with a western saddle. Silver show tack will not count over good work tack. All Legal Tack Permitted. Legal Shank bit ridden one handed, or legal snaffle bit or bosal ridden two handed. Shank bits may be ridden two handed if approved by judge and steward for select classes.

### **LEGAL TACK:**

Maximum overall shank length on bits is 8.5".

Western snaffle bits (center jointed, single rounded mouthpiece of 3/8-3/4" in diameter) are acceptable for horses five (5) years or younger (or on a Green Horse 1<sup>st</sup> or 2<sup>nd</sup> year of showing in an MHSA Show, regardless of age). If a curb strap is used, it must be attached below the reins.

Horses shall not be shown with mechanical hackamores, cavesson type nosebands, martingales or any type of tie down. A rounded hackamore or bosal, constructed of braided rawhide, is permitted for horses five (5) and under (or on a Green Horse 1<sup>st</sup> or 2<sup>nd</sup> year of showing in an MHSA Show, regardless of age).

Bandages and protective boots are generally prohibited. However, in Versatility Ranch Horse & Working Cow Boxing Classes, the use of bell boots, protective wraps or boots on the front and on the rear fetlocks are permitted. **For more info on tack:** Refer to USEF WS: 105 <https://www.usef.org/forms-pubs/pEljSmr3BAU/western-equipment-booklet> :

### **WS105 Tack**

1. Competitors must be penalized for incomplete appointments but not necessarily disqualified. Entries shall be shown with stock saddle but silver equipment will not count over a good working outfit. A sidesaddle shall be considered legal equipment. Breast collars are acceptable. Tapaderos are prohibited.

2. There shall be no discrimination against any standard Western bit. A standard Western bit is defined as having a shank with a maximum length overall of 8 1/2". The mouthpiece will consist of a metal bar 5/16" to 3/4" in diameter as measured one inch in from the shank. The bars may be inlaid but must be smooth or latex wrapped. Nothing may protrude above or below the mouthpiece (bar) such as extensions, prongs or rivets designed to intimidate the horse. Rollers attached to the center of the bit are acceptable, and may extend below the bar. Jointed mouthpieces are acceptable and may consist of two or three pieces and may have one or two joints. A three-piece mouthpiece may include a connecting ring of 1 1/4" or less in diameter or a connecting flat bar of 3/8" to 3/4" (measured top to bottom with a maximum length of 2"), which lies flat in the mouth, or a roller or port as described herein. The port must be no higher than 3 1/2"

maximum with roller(s) and covers acceptable. Jointed mouthpieces, half-breeds and spade bits are standard. Slip or gag bits, rigid donut mouth- pieces and flat polo mouthpieces are prohibited. Roping bits with both reins connected to a single ring at center of cross bar shall not be used. Reins must be attached to each shank. Any rein design or other device which increases the effective length and thereby the leverage of the shank of a standard western bit is prohibited. Anything that alters the intended use of equipment as provided for in the description of appointments for a given class is considered to be an artificial appliance.

3. Standard snaffle bits are permitted in any class on a junior horse five years old and under (*or on a Green Horse in their 1<sup>st</sup> or 2<sup>nd</sup> year of showing in an MHSA Show, regardless of age*). A standard snaffle bit is defined as a center jointed single rounded, unwrapped smooth mouthpiece of 5/16" to 3/4" diameter metal as measured from ring to 1" in from the ring with a gradual decrease to the center of the snaffle. The rings may be from 2" to 4" outside diameter of either the loose type, eggbutt, dee or center mounted without cheeks. The inside circumference of the ring must be free of rein, curb or headstall attachment hooks. If a curb strap is used it must be attached below the reins. Closed reins (example mecate) on a snaffle bit are prohibited.

4. Hackamores are permitted in any class on a junior horse five years old and under. A hackamore includes a bosal rounded in shape and constructed of braided rawhide or leather and must have a flexible non-metallic core attached to a suitable headstall. No other material of any kind is to be used in conjunction with a bosal, i.e., plastic, resin, glue, steel, metal or chains (Exception: smooth plastic electrical tape is acceptable if applied in a smooth, untwisted manner). There must be approximately 3/4" between the nose and the bosal. The bosal will be no larger than 3/4" in diameter at the cheek and will flex easily. Attached reins may be of hair, rope, or leather.

5. Horses shall not be shown with artificial appliances that would tend to alter their performance. Curb chains and leather chin straps may be used but must be flat and at least 1/2" in width and lie flat against the jaws of the horse. No wire, rawhide, metal or other substance can be used in conjunction with or as part of the leather chin strap, or curb chains. Rounded, rolled, braided or rawhide curb straps are prohibited. A light lip strap is permissible. Hackamore bits, bosals, cavesson type nosebands, martingales and tie-downs are prohibited. A judge does not have the authority to add or to remove any of the standard equipment as specified above.

6. Bandages and boots of any type are prohibited. In the event of injury, the Judge may permit a protective band- age. *In Versatility*

*Ranch & Working Cow Horse classes, the use of shin, bell boots and/or protective bandages on the front legs and standard sliding or rundown boots on the rear fetlocks are permitted.*

#### **GENERAL RULES AND INFORMATION:**

No other persons besides show management or their representative may approach the Judge during the show. Questions or concerns should be directed to the Show Steward/Adjudicator. Approaching the Judge prior to the completion of the last class may result in disqualification from the show and/or a possible fine to be determined by the MHSA Awards Committee.

#### **MHSA MEMBERSHIP:**

Competitors and horses must be current members of the MHSA in order to qualify for MHSA Year-End Awards. Current membership numbers must be included on entry blanks or a competitor must hand in completed Membership Form prior to competing. (NOTE – ALL CLASSES & DIVISIONS OFFERED AT SHOW COUNT TOWARD MHSA YEAR END AWARDS)

#### **VOLUNTEER SUPPORT:**

MHSA is an all-volunteer organization. We need parents, riders, & supporters to actively help us man the horse shows. Please contact the **Show Manager Lehua Gardanier (phone number 281-3290 or email lkua@aol.com)** for volunteer opportunities associated with this show.

#### **CLASSES:**

**STOCKSEAT EQUITATION:** Horses will be asked to work at a walk, jog, and lope, (or only walk and jog if entered in Walk/Jog division) both directions of the arena and will be judged on riders' positions and horsemanship. May be asked to perform individual tests, at the discretion of the judge. The horse's quality of movement is not a major factor.

**PLEASURE:** Horse to be shown on the rail, at the walk, jog, and lope, (or only walk and jog if entered in Walk/Jog division) both directions of arena. At the Judge's discretion, an extended jog may be requested. Horses must stand quietly, reverse and back willingly. Horses should work on a reasonably loose rein, maintaining consistent, relaxed gaits and making smooth transitions. Judged predominantly on quality of gaits and manners, as well as suitability of horse to rider. Rider's equitation is not a major factor. Passing is not penalized, as long as each horse is working at a pace appropriate to their size and stride.

**TRAIL:** Horses to work individually, over and through an obstacle course. This may include walk, jog, lope, (or only walk and jog if entered in Walk/Jog division), back, side pass or tight turns. To be judged on rein work, manners and accuracy of the pattern. Off pattern will result in disqualification. Obstacles may include but are not limited to: negotiating a gate, carrying objects from one place to another, crossing a bridge, crossing logs, backing through obstacles, side-passing over a log, etc. Pattern will be posted at least one hour before the class. No part of the pattern will be designed to advantage a very large or very small horse. Manners, responsiveness and general attitude in completing the course are the major factors in this class. Any balking, delays or refusals will be penalized. A horse that refuses may be directed to continue to the next obstacle, or be excused.

**IN HAND TRAIL:** Open to horses of all ages, breeds and genders. Horses are to be lead in a flat halter, nylon or leather with a chain, through a designated trail course. The chain may be used under the chin or hanging from the halter. Exhibitor is not allowed to touch the horse, except when sidepassing. Each exhibitor will be asked to perform individually, a pattern that may include walking, trotting, backing and turning. Obstacles may include but are not limited to: crossing a bridge, crossing logs, backing through obstacles, pivoting in a box, etc. The pattern will be posted before the show begins. Precision, accuracy, manners and willingness are rewarded.

**WESTERN RANCH RIDING:** Horses show individually through a pattern. In this class, judges are looking for relaxed, responsive horses with soft and cadenced gaits. The horse should make timely transitions in a smooth and correct manner, plus the horse should be soft in the bridle and yield to contact. Should reflect the versatility, attitude, and movement of a working horse; overall manners and responsiveness of the horse while performing maneuver requirements and the horse's quality of movement are the primary considerations.

**VERSATILITY RANCH TRAIL:** Obstacles found in a ranch trail pattern are approximate to those found during the course of everyday work. Judges are looking for a well-trained, responsive and well-mannered horse that can correctly navigate and negotiate the course, and to do so in a correct and efficient manner. Rule SHW561 outlines the class, including prohibited and mandatory obstacles.

**VERSATILITY RANCH REINING:** Ranch Reining measures the ability of the stock horse to perform basic handling maneuvers. Judges are looking for: "To rein a horse is not only to guide him but also to control his every movement. The best reined horse should be willingly guided or controlled with little or no apparent resistance and dictated to completely."

**WORKING COW HORSE BOXING:** Each contestant, upon receiving a cow in the arena, shall hold that cow on the prescribed end of the arena for 50 seconds, demonstrating the ability of the horse and rider to control the cow. Time shall begin when the gate closes behind the cow after being let into the arena. The announcer or judge will signal the completion of the 50 seconds with a whistle or horn.

**WORKING COW HORSE BOX DRIVE BOX:** Exhibitors are allotted one minute and forty five seconds to complete the cow work. Time shall begin when the gate closes behind the cow after being let into the arena. When there are 30 seconds left, the announcer will announce, 30 seconds remaining. At one minute and forty five seconds, the announcer will call for time. Exhibitors are not required to use all of the allotted time but must ride until the judge ends the run with a whistle or time expires, whichever occurs first. There are four parts to the work: boxing the cow; setting up the cow and driving / rating it down the fence to the opposite end of the arena; and boxing it at the opposite end of the arena, and then driving / rating the cow past the middle marker again. There is no expectation that the exhibitor will make a 'fence turn,' rather the drive down the fence demonstrates correct position and control around the corner

#### **RANCH SORTING:**

\$25 per rider

You can select your helper on the day of the show. You can only enter one run per division. Class entry can be done on the day of the show. Class will take place in Cutting Arena.

\*\*\*No Practice Run \*\*\*

Sorting only 1 cow out of a herd of 10. Each cow will be given a number taped to their back. The cow number will be announced when the rider enters the pen before time starts. The helper will stand near the entry gate to help the rider to allow the correct cow to enter. This makes it a little easier and slower to work with and less intimidating to those who are just learning. It also matches the pen size so there is enough room to get around the herd without scattering.

Herd will be rotated after every 5 riders or divisions depending on how many cattle are available for fairness to competitors.

DQ for sorting the wrong cow, more than one cow crossed over the entry gate, re-entry of cow into the sorting pen once it has crossed over the entry gate completely and excessive scattering. If a rider is DQ's for any reason, the run will end immediately for the best interest of the stock. 2-minute time limit

Time only applies to those that sort correct cow. Failure to sort the correct cow will be considered a No Score. Fastest time will determine 1st place.

Placing/ Points awarded per rider that is sorting. Helper will not get points or placing. You are allowed to be a helper to multiple riders.

Ribbons 1st - 6th place be given to the rider with the fastest time in each class.

Class Placing points will count toward MHSA Division End of Day awards. (Open class will not count)

#### **DIVISIONS:**

**WALK/JOG 13 AND UNDER:** This division is designed for riders 13 years old and under (as of December 1), and riders OR horses returning after a two-year hiatus who are not ready to compete in classes that require loping. Horse/rider combination may not crossover into a loping division. CLASSES: Stock Seat Equitation, Pleasure, Trail, Western Ranch Riding

**WALK/JOG 14 AND OVER:** This division is designed for riders 14 years old and over (as of December 1) and beginning horses, and riders OR horses returning after a two-year hiatus, who are not ready to compete in classes that require loping. Green Horse Rules Apply to the Beginning Horse for this division. Horse/rider combination may not crossover into a loping division. CLASSES: Stock Seat Equitation, Pleasure, Trail, Western Ranch Riding

**JUNIOR 17 AND UNDER:** Restricted to exhibitors 17 years and younger (as of December 1<sup>st</sup>). Riders will be asked to walk, jog, and lope in all classes. CLASSES: Stock Seat Equitation, Pleasure, Trail, Western Ranch Riding

**ADULT 18 & OVER:** Restricted to exhibitors 18 years and over (as of December 1). Riders will be asked to walk, jog, and lope in all classes. CLASSES: Stock Seat Equitation, Pleasure, Trail, Western Ranch Riding

**VERSATILITY RANCH & WORKING COW HORSE - JUNIOR 17 & UNDER** CLASSES: Versatility Ranch Trail, Ranch Sorting, Versatility Ranch Reining, Working Cow Horse Boxing, Working Cow Horse Box Drive Box

**VERSATILITY RANCH & WORKING COW HORSE - ADULT 18 & OVER** CLASSES: Versatility Ranch Trail, Ranch Sorting, Versatility Ranch Reining, Working Cow Horse Boxing, Working Cow Horse Box Drive Box
